APPROVAL OF MINUTES

Pam Godby, Human Resources Director reported that since her last report at the board meeting in December 2010; we have had six (6) employees go off duty-(3)three retired and (3)three resigned; we have hired two (2) part-time nurses; and one (1) APRN.

POLICIES UPDATE

Mr. Crabtree explained to the board that he needed approval for some minor changes in several of our current policies; he said that each department head with a change in their respective policy would be presenting the policy change tonight:

Laura Woodrum presented changes concerning Family Planning Clinics, and deleted contraceptives; Dr. Smith moved to accept the changes; Judge Huff seconded the motion. *Motion carried*.

Melinda Copenhaver presented changes for LEP (Limited English Proficiency), Register Guidelines and Religious Exemptions; Judge Misty Sexton moved to accept the changes; Rosalie Wright seconded the motion. *Motion carried*.

FINANCIAL REPORT/DIRECTORS COMMENTS/FURLOUGHS

Shawn Crabtree reported to the Board that we are projecting a 2 million dollar ending year deficit and to start next year around a 1 million dollar deficit. Hopefully, things will be a little better than that but probably not much. External threats to our funding still exist and we should all let our elected state and federal officials know about our pain. Public Health isn't immune to sharing the nation's economic woes, but we need to make sure the policy makers understand how our organization and communities are impacted.

He also explained to the Board about how our clinic nurses have reduced through attrition in the last couple years by about 20% and how our Health Education branch has reduced by 50%. Also, our School Branch is operating at a minimum staffing compliment. He told the board members that we have no choice at this point but to start hiring nurses when we have turn-over because the remaining staff can't meet the community demand.

Mr. Crabtree told the board members he was discouraged about the new WIC program roll-out. I know it has caused stress for our clerks and patients (and other staff). We have done what we can to intervene. At least most of the issues will resolve themselves over the next few months as we get all our patients transitioned into the new system.

He did add some more hopeful notes. The financial adjustments we have made as an agency will allow our reserve to stretch several more years and hopefully last long enough to weather this economic downturn. While our restructuring and recovery is slow, it is happening.

We are actively developing a "Wellness Profile Program" to attach to our website which our citizens can complete and receive customized wellness scores and suggestions; and a referral letter for needed health screenings.

Local Health Boards are increasing their contribution rates from 1.8 cents to 2.8 cents as required by the District Board of Health as minimum payment to participate in the district. Here is a summary so far: Clinton, Adair, Green, Taylor, Pulaski, Casey, Russell and McCreary have officially met and all, after healthy debate, voted to pay the new participation rate. Four major themes, from my perspective, have surfaced: 1) there is an understanding that the health department's services impact all citizens, 2) there is satisfaction with how the district is ran, 3) while no one wants to raise taxes there is an understanding that health departments have experienced major, unavoidable funding reductions, and 4) there is a realization it would cost more to be out of the district rather than be in it. Wayne and Cumberland Boards meet later this week.

Mr. Crabtree discussed the recent staff furlough days. He reported that since we lose revenue on the days we are furloughed the only way furloughs help us is to make up the lost revenue on later days. Since attrition has lowered our staff size it is becoming more and more difficult to make up this lost revenue. Thus the benefit of furloughs is waning. Our lower staff compliment is also starting to create some overtime in our clinics for the days that we are seeing patients. Mr. Crabtree said the board members might want to reconsider their former recommendation for three more furlough days to be added to the new fiscal year for 2011-2012.

Judge Rogers thanked Mr. Crabtree for keeping the members informed of the current financial status of the health department and thanked him for all he is doing to help during these declining economic hardships that everyone is experiencing.
