## AUDIT REPORT

Ken Dougherty, CPA from Brown & Dougherty presented his recent audit report of the Lake Cumberland District Health Department. Mr. Dougherty explained that the audit was unqualified and was a clean audit with all internal controls in place. He also said that all staff was very helpful and courteous. Judge Rogers moved to accept the audit. Judge Phelps seconded the motion. *Motion carried*.

## HUMAN RESOURCES REPORT

Pam Godby, Human Resources Director, reported that since the last HR report at the September meeting; we have had four (4) employees go off duty and five (5) new staff hired.

## FINANCIAL REPORT

Shawn Crabtree, Executive Director presented the current financial report to the board. Mr. Crabtree expressed his appreciation to the board members for their dedication to the health department. He voiced his concerns regarding the current situation with the managed care companies which have contracted with the Department for Public Health in Frankfort. One of these companies hasn't paid our health department for any services this year and if this continues, this will affect our budget by approximately a 1.5 million deficit this year.

Our plans are to take from our reserves to cover this deficit but if this continues our school program and other clinic programs, eventually, will be in jeopardy.

#### ACCREDITATION UPDATE

Mr. Crabtree said that we are working on our accreditation and that the PHAB is up and going and they are working with three (3) health departments in the state that have turned in applications for accreditation. We are planning to continue to work toward accreditation but will wait to see the outcomes of the three other health departments and their results. It is likely we will seek accreditation during the 2013/2014 fiscal year.

#### EMPLOYEE SATISFACTION SURVEYS

Mr. Crabtree reported that the recent Employee Satisfaction Surveys were completed and the results show that (88) employees completed the survey. Generally the survey was comparable to last year's without significant changes.

## APA (AUDITOR OF PUBLIC ACCOUNTS) UPDATE

Shawn Crabtree briefly explained to the board about the House Bill 1 pertaining to the Auditor of Public Accounts and their recommendations for the thirty one (31) standards that they use.

#### POLICIES UPDATE

Janae Tucker presented to the board two updates to our current policies: One relating to the clinic explained by Laura Woodrum regarding breast feeding in our clinics; and the second one stating that employee vaccinations are mandatory.
